





## Protecting the People of Los Angeles County

With 10.3 million residents, Los Angeles County is the most populous county in the nation and is larger than 42 states. The county spans 4,083 square miles, stretching from the Antelope Valley to Long Beach and from Pomona to Malibu.

Felony cases are prosecuted in downtown Los Angeles courthouses and in 40 branch, area and juvenile courts. The District Attorney's Office also prosecutes misdemeanors in many regions of the county.

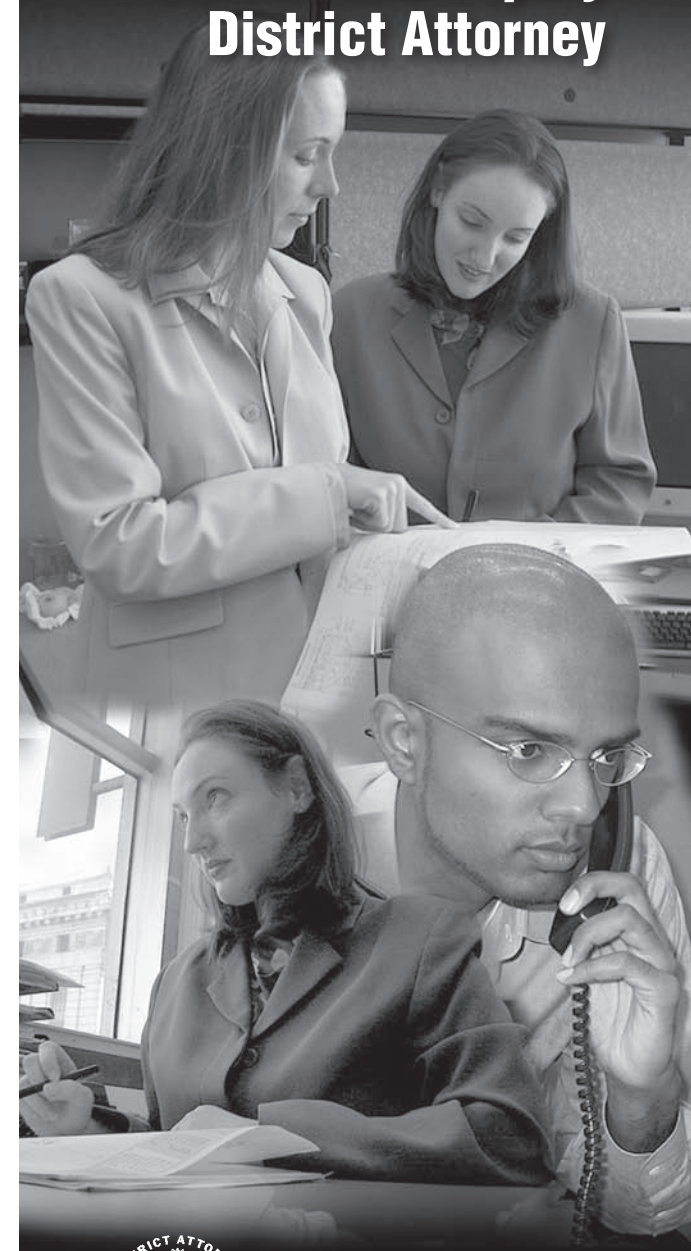
More than 2,200 people are employed in the District Attorney's Office, including more than 1,000 lawyers. The District Attorney's 294 investigators have full peace officer status, with the same jurisdictional authority as Los Angeles County deputy sheriffs. The office also employs paralegals, law clerks, witness assistants and victim services representatives.

## Volunteer Law Clerk for First- and Second-Year Law Students

Early in your legal education you can lay the foundation for a career in a public prosecutor's office by serving as a volunteer law clerk. Volunteer law clerks assist deputy district attorneys in all phases of trial, both felonies and misdemeanors, and will likely attend hearings in court on cases.

In addition, volunteer law clerks may be asked to assist in:

- Legal research
- Reviewing transcripts for inconsistent statements
- Trial strategy discussions
- Collecting and analyzing statistics
- Research and special studies on issues affecting individual cases or projects
- Preparing reports or documents
- Contacting or assembling witnesses
- Compiling case evidence notebooks and sorting evidence
- Related tasks, including clerical work

**Minimum commitment:** Twelve hours per week, six weeks; positions available spring semester, summer session and fall semester.

All volunteer law clerks and certified law clerk externs must pass a background investigation.

### How to apply:

- Send a cover letter, resume and most recent school transcript to the District Attorney's Recruitment Coordinator (see back page).

## Certified Law Clerk Externships for Third- and Fourth-Year (Evening) Students

Direct courtroom experience is the goal of this semester- or summer-long externship, with a focus on courtroom trial skills. Under rules of the State Bar of California, law students who have completed courses in Civil Procedure and Evidence may make appearances in court under the supervision of a deputy district attorney. Assignments are available during both school semesters and also during the summer and are preceded by a one-day training session on how to conduct a felony preliminary hearing or a juvenile adjudication. Training is provided in January, May and August each year. Certified law clerks are assigned to the District Attorney's Central Operations Preliminary Hearing Unit and branch, area and juvenile offices around the county.

**Minimum commitment:** 16 hours a week; accommodation available for split summers. Full-time, semester-long externships are also available.

All volunteer law clerks and certified law clerk externs must pass a background investigation.

### Application deadlines:

- Mid-February for summer
- End of June for fall
- End of October for spring

### How to apply:

- Send a cover letter, resume and most recent school transcript to the District Attorney's Recruitment Coordinator (see back page).

## Paid Senior Law Clerk Positions for Law School Graduates

The paid senior law clerk positions offer hands-on case development and trial preparation experience. However, you will not have the opportunity to be a State Bar certified law clerk and this is not a deputy district attorney-trainee position. Hiring is limited to certain divisions and occurs throughout the year. You must have graduated from law school and received your final law school transcript in order to apply for these full-time positions. Interviews are conducted in these divisions when positions are available:

- Appellate Division, Habeas Corpus Litigation Team
- Automobile Insurance Fraud Division
- Major Fraud Division, Real Estate Fraud Section
- Public Integrity Division, Internal Welfare Fraud Unit
- Specialized Litigation Division, Child Abduction and Elder Abuse Sections
- Welfare Fraud Division
- Healthcare Fraud Division

### How to apply:

- Fill out a District Attorney employment application
- Attach a copy of your official final law school transcript showing the date your degree was awarded
- Attach your resume
- Send the original application to the Human Resources Division (address on back panel)

## Deputy District Attorney Hiring

A genuine interest in a career in public service, the ability to think clearly on your feet and the energy and enthusiasm to do trial work are all qualities we seek in a good candidate for deputy district attorney. You can prepare for this career while still in law school by:

- Participating in moot court and/or trial advocacy programs and competitions
- Taking advanced level criminal law course work
- Doing an externship in a prosecutor's or public defender's office

You must pass the California Bar examination in order to file for the position of deputy district attorney I and U.S. citizenship is required at time of appointment.

Two-week application filing periods are traditionally held in June and December, immediately after Bar results are announced. However, this schedule is dependent on office needs and budgetary considerations.

### How to apply:

- Send a letter and resume to the Recruitment Coordinator (address on back panel), and you will be notified of the next application period.
- Applications are available on the District Attorney's Web site.
